An Act to charge on the Consolidated Fund certain debts and the Pensions and Gratuities granted to or in respect of Members of the Unified Teaching Service and to increase the maximum sum which may be charged on the Consolidated Fund under the Presidential Affairs Act. 1962

[9TH JULY, 1965]

ENACTED by the Parliament of the United Republic of Tanzania.

- 1. This Act may be cited as the Consolidated Fund (Miscellaneous Short title Provisions) Act, 1965.
- 2.—(1) The principal monies and all interest and other charges Debts in payable in respect of the debts and liabilities set out in the Schedule to be charged on hereto are hereby charged upon, and shall be paid out of, the Consolida-Consolidated ted Fund without further appropriation than this Act.

(2) The payment by the Treasury prior to the commencement of this Act, in discharge of any amount due and owing in respect of the debts and liabilities aforesaid, of any sums specified for such purposes in the estimates of expenditure laid before the National Assembly is hereby confirmed.

3. The sums required for the pensions and gratuities payable to or in Pensions, etc. respect of members of the Unified Teaching Service in accordance with Teaching regulations made in that behalf under the Unified Teaching Service Service to Act, 1962 are hereby charged upon, and shall be paid out of, the be charged on Consolidated Fund without further than the paid out of, the Consolidated Consolidated Fund without further appropriation than this Act.

- 1. The indebtedness of the Government to the Standard Bank Limited in respect of the liabilities of the Makonde Water Corporation which were vested in the Government by the Makonde Water Supply Act, 1962, in the principal sum (as at the eleventh day of January, 1963) of Shs. 9,480,686 and cents 65.
- 2. The indebtedness of the Government to the East African Power and Lighting Company Limited in respect of the purchase by the Government of the ordinary stock of the said Company in the Tanganyika Electric Supply Company Limited, in the principal sum (as at the twenty-seventh day of April, 1964) of Shs. 59,700,000.
- 3. The indebtedness of the Government to the Lint and Seed Marketing Board in respect of the loan of £1,000,000 made in accordance with terms approved by the Legislative Council on the twelfth day of February, 1954.
- 4. The indebtedness of the Government to Stirling-Astaldi (Africa) Limited in respect of the arrangements for contractor-financing of road projects provided for in an exchange of letters in March, 1961, in the principal sum (as at the first day of July, 1965) of £800,000.
- 5. The indebtedness of the Government to the Government of the Union of Soviet Socialist Republics under an agreement made on the twenty-third day of August, 1964, in the principal sum (as at that date) of £274,000.
