An Act to amend the Customs Tariff Act, 1969

[1ST JANUARY, 1971]

ENACTED by the Parliament of the United Republic of Tanzania.

1. This Act may be cited as the Customs Tariff (Amendment) Act, 1971, shall be read as one with the Customs Tariff Act, 1969 and shall be deemed to have come into operation on the first day of January, 1971. Short title and commencement Act, 1969 No. 54

2. The First Schedule to the Customs Tariff Act, 1969 is amended by substituting, save where the word "(same)" occurs, for the entries in the column headed "Tariff Heading" and the entries in the columns headed "Fiscal Entry" and "Import Duty" opposite to the following tariff numbers the following respective new entries:— First Schedule amended

Construction

3. The word and brackets “(same)” where appearing in the amendments made by this Act to the First Schedule to the Customs Tariff Act, 1969 mean that, except as specifically amended by this Act, the tariff heading or the fiscal entry, suspended fiscal entry or import duty (according to the column in which the tariff number in relation to which such word and brackets appear) shall continue the same as it was immediately prior to the coming into operation of this Act.
