An Act to amend various written Laws relating to pension

ENACTED by the Parliament of the United Republic of Tanzania.

1. This Act may be cited as the Pension Laws (Miscellaneous Amendments) Act, 1991, and shall come into operation on the 1st day of April, 1991.

Short title and commencement

2. The various laws set forth in the first and second columns of the Schedule to this Act are hereby amended in the manner specified in the third column.
